# JEL Secures the Sabiya Combined Cycle Gas Turbine Project Subcontract from Hyundai Heavy Industries Co. Ltd

JEL recently secured a project from Hyundai Heavy Industries Co. Ltd (HHI) for the Sabiya Combined Cycle Gas Turbine Project (Sabiya CCGT Project) in Sabiya Power Station, Kuwait, under the Ministry of Electricity and Water (MEW).

The Sabiya CCGT Project was secured after JEL's successful completion of the supply, manufacture, and mechanical and E & I erection of 8 units of Heat Recovery Steam Generators at the Azzour South Combined Cycle Power Plant (Azzour South Project) in Kuwait, under Siemens / CMI.

The negotiations before the award of the subcontract were tough because there were a number of competitors, both local and international. However, despite these competitors having previously worked with HHI on various similar projects in Saudi Arabia, Bahrain and other Middle-Eastern countries JEL was awarded the subcontract.

JEL's scope of work for the Sabiya CCGT Project is for the erection of mechanical equipment (BOP), and the installation of Piping and Pipe Rack Steel Structure for the Power Block A Package. Although the Sabiya CCGT Project execution began in earnest in the first week of May 2010, JEL diligently started its work preparations as early as April 2010. The erection of the pipe rack steel structure and mechanical equipment BOP commenced in June 2010.

The project site, situated 100km north of Kuwait City, is more deserted and open than the Azzour South Project site, with extremely hot weather during summer. Further challenges include JEL having to manage a workforce made up of multiracial staff and workers. During the peak of construction work, the workforce

is estimated to reach manpower numbers of 550, comprising more than a dozen nationalities who must execute the project in a harsh desert environment with an average temperature of 50°C.

The Sabiya CCGT Project, though a great challenge for JEL, presents a chance for JEL to prove once again that it is one of the strong players in the erection and building of power plants business.

With JEL's experience and dominance in the power plant industry, bolstered by its recent involvement in the Azzour South Project, it is expected that the Sabiya CCGT Project will also be accomplished with flying colors; and JEL will be well on its journey to expand its horizons to new territories in the Middle-Eastern region.

## New Contract for the Construction of a 110MW Gas-Fired Cogeneration Power Plant at Siam Industrial Park

In January 2010, Thai Jurong Engineering Ltd, a subsidiary of Jurong Engineering Ltd, secured a contract for the construction of a 110MW gas-fired cogeneration power plant ("the Plant") for Thai National Power 2 Co Ltd at Siam Eastern Industrial Park.

The Plant is based on General Electric LM6000PF gas turbines in a 2+1 configuration with steam extraction from the steam turbine. It is planned that 90MW of the output will be sold to the Energy Generating Authority of Thailand, with the balance 20MW sold to industrial users. The work for the new plant commenced in July 2010 and the Plant will be operational in 2012.

With the award of the contract, Thai Jurong Engineering Ltd has again established itself as a leading and trusted power plant builder in Thailand.

While Thai Jurong Engineering Ltd has been entrusted with the construction of the Plant, our parent company, IHI Corporation, was awarded the contract for the engineering, procurement and manufacturing, as well as the supply of major equipment to be imported into Thailand to be incorporated into the Plant. The award of the contract to IHI Corporation is testimony of the confidence international companies in the power industry have in the capability, technology and reliability of IHI Corporation as one of the reputable power plant constructors in the world.

Thai National Power 2 Co Ltd is a 100% subsidiary of Thai National Power Company Ltd, which currently owns a 143MW gas-fired power plant adjacent to the Plant. The parent company of Thai National Power Company Ltd is International Power PLC, which is a leading independent power generation company that owns and operates many power plants across the regions of Asia, North America, Europe, Middle East and Australia.

## Bird's Nest Soup A Tonic for Health & Beauty

Bird's nests have been used in Chinese cooking for over 400 years, most often as bird's nest soup. A few species of swift, particularly the cave swifts, are renowned for building the saliva nests used to produce the unique texture of this soup. The edible bird's nests are amongst the most expensive animal products consumed by humans.

Regarded as a delicacy in Chinese cuisine, bird's nest soup is rich in protein, vitamins and essential minerals. It is reputed to benefit our lungs and digestive tract, and at the same time boost our immune system. It is also believed that bird's nest soup rejuvenates and smootheners our complexion, while keeping skin looking youthful and radiant.

## How to Prepare Bird's Nest Soup?

Bird's nests can be used to make both soups and desserts. As a savoury soup, it is often prepared using a good chicken stock and some Chinese ham. As a dessert, it can be prepared by simply adding some rock sugar.

In this issue, Ms Lin Lan is sharing her authentic Chinese recipe for sweet bird's nest soup, which is very simple to prepare at home.



## Double-Boiled Bird's Nest Soup with Rock Sugar



### Ingredients

Bird's nest .....20 gm  
Rock sugar .....add to taste  
Water .....600 ml

### Utensils

Double boiler\*

### Method

1. Soak the bird's nest in fresh water for 1 hour until it is softened.
2. Clean it gently and pick out any feathers or dirt. Rinse well and squeeze dry.
3. Add appropriate amount of plain water to the lower chamber of the double boiler and bring to a boil.
4. Place the bird's nest with 600 ml of water in the top chamber of the double-boiler and simmer on low heat.
5. After 15 minutes, add some rock sugar to taste. Continue to simmer for another hour.
6. Serve the bird's nest soup hot or cold, according to your preference.

\* If you do not have a double boiler, you can improvise by selecting two saucepans or stockpots in varying sizes. Ideally, the pot on top should nest snugly into the top portion of the larger and deeper pot. Add water to the lower chamber, but remember to leave at least one inch of space between the water and the chamber holding the food.
