EARLY COMMERCIAL OPERATION OF SAHACOGEN EXPANSION PROJECT - 3

In order to meet the increased demand for power and steam from its customers, Sahacogen (Chonburi) Public Company Limited ("Owner") has decided to expand the existing combined cycle power plant facility, with a capacity of 184 MW and 80.5 TPH process steam, at the Saha Pathana Group Industrial Park – Sriracha in Chonburi, Thailand.

The EPC contract for the new expansion project, namely, Sahacogen Expansion Project-3. which will provide a gross output of 24 MW and 15 TPH process steam, was awarded to JEL and TJEL on 22 December 2015. The new expansion facility comprises one train of Gas Turbine Generator, HRSG and Steam Turbine Generator and associated Balance of Plant. JEL's scope was for the design and engineering of the expansion facility and the supply of equipment whereas TJEL's scope was for local procurement, installation, erection, testing, commissioning and warranty services.

A narrow plot of land was allocated for the expansion project adjacent to the existing power plant facility. The plant design was optimized to accommodate the new facility as it was a challenge to the construction team to bring in and erect large components of HRSG and Gas Turbine. Construction plan and lifting cranes were well prepared and with good co-operation from Owner and neighbouring plants, all main equipment were installed without any issue. Tie-ins to existing plant were planned and executed in coordination with the operating plant.

Overall construction, testing and commissioning went well and the project was successfully handed over to Owner on 20 December 2017. The commercial operation of the expansion project started one month ahead of schedule on 20 November 2017. Early commercial operation and a better than guaranteed plant performance were well appreciated by the Owner.

This is the fifth EPC project that JEL has successfully executed for Sahacogen, exemplifying the faith from our esteemed customer on JEL's engineering and project management services.



UPDATES ON JEL MAINTENANCE

SUCCESSFUL PROJECT COMPLETION: K2C & KRP PROJECTS, GEBENG, MALAYSIA

JML was the mechanical and piping contractor for the construction of the Kuantan 2nd Crystex Plant (K2C) Project & Kuantan Resin Plant (KRP) for Eastman Chemical (Malaysia) Sdn Bhd managed by Jacobs Engineering Group Malaysia Sdn Bhd. JML started work in January 2016 and carried it through to successful completion on November 2017 as per project's schedule. Throughout the project, the JML team executed the work efficiently with high safety standards. JML's safe working methods contributed to "5+ Million Safe Work Manhours" achieved for K2C & KRP Projects.



SUCCESSFUL PROJECT COMPLETION: EQUATE TURNAROUND 2017, KUWAIT

JML received its successful completion certificate from Equate Petrochemical Company for its Major Turnaround 2017 – Aromatics Package - Mechanical Lumpsum Scope in November 2017, two days ahead of schedule and was duly rewarded with early completion incentive. Aromatic plants in Equate Petrochemicals was majority owned and operated by Dow Chemicals and PIC (Kuwait Petroleum Company). JML is one of the major contractors involved in TA-2017 and successfully completed the works with no major incidents and "Zero-Leak Performance". With this, JML could be an automatic choice for Equate for future Maintenance & TA programs.



PROJECT AWARD: EVONIK Me6 PROJECT AT JURONG ISLAND, SINGAPORE

JML was awarded another contract from Amec Foster Wheeler Asia Pacific Pte Ltd, who intends to build a new production complex adjacent to recently completed similar facility at Jurong Island, Singapore for Evonik Methionine (SEA) Pte Ltd. JML will carry out mechanical and piping works, erection & testing, tie-ins, equipment installation, painting works, scaffolding works, inspection and testing, turnover and handover activities. This integrated complex (Me6) will produce methionine and all strategically important intermediates, doubling the capacity of the existing plant. The project was awarded last August 2017 and scheduled to be completed by October 2018 with a span of 14 months and peak manpower of 450.

Mae Moh Coal-Fired Power Plant Units 4-7 Replacement Project consists of one unit of supercritical boiler with a gross output of 600 MW. The main plant consists of boiler, turbine generator, balance of plant systems, tanks, ESP and related electrical and control systems. The site is located near the existing power plant in Lampang District, Thailand.

The tender for Mae Moh B30 & B35
Turnkey Project started in May 2015
after Alstom and TJEL met to discuss
the Request for Quotation (RFQ) in
Alstom's Beijing office and TJEL's
Bangkok office. The project was
awarded to TJEL and the contract
was signed on 22 March 2016. The
project was substantially completed
with all the building services
functioning on 15 March 2018. Power
plant commercial operation will be on
13 November 2018.

The Mae Moh B30 & B35 Turnkey Project scope of works included engineering, procurement, and construction (EPC) of Central Control

Building (B30) and Boiler and ESP Electrical Building (B35). B30 has a 4500 square meters usage area, 5 floors of building and B35 has a 1350 square meters usage area and 3 floors of building. Our scope of works included EPC of B30 and B35 interior decoration, architectural, foundation, structural, sanitary, drainage and landscaping, lighting and earthing, HVAC, and fire-protection works. During the detailed design, interface with the client's and owner's departments were taken care by TJEL. 3D modelling of structure, building services, and interior decoration was utilized as required by client to minimize work interface problems.

PENGERANG COGENERATION PLANT

Equator Engineering Sdn Bhd (EESB) commenced construction work at Pengerang Cogeneration Plant on 7 January 2016 and successfully achieved the first gas turbine fire on 1 August 2017. The plant has been generating an output of 375 MW since 8 August 2017, followed by second gas turbine with a capacity of 375 MW since 11 September 2017.

We conducted the steam blow out from Heat Recovery Steam Generator ("HRSG-11") to Steam Turbine Unit 31 and 32 on 16 November 2017.

The project has since started commercial operation, supplying an added capacity of 900 MW to Malaysian National Grid.

The balance of two gas turbine units

and two HRSG will begin operation by end April and July 2018 respectively.

EESB's dedication and hardwork were paid off by achieving 11,362,310 safe man-hours without lost time injury, and was presented the "Project Achievement Award" from Siemens.

In addition, Petronas issued "Focus Recognition Award" to EESB in recognition of the successful execution of Pengerang cogeneration project towards delivering commercial operation date ("COD") 1 on time, without compromising on safety, within budget and meeting the quality requirement.



The awards were strong affirmation of EESB's competencies in fulfilling the RAPID project requirements.

JEL (BORNEO) SDN BHD SPONSORS NEW MINI PLANT WHICH HELPS DEVELOP JOB-READY GRADUATES

On 18 January 2018, JEL (Borneo) Sdn Bhd, amongst others, officially sponsored the opening of a newly constructed Hand-on Operation Training Skids Unit at the Institute of Brunei Technical Education (IBTE) (Jefri Bolkiah Campus).

This mini plant project was a joint collaboration between IBTE and the Energy and Industry Department of Prime Minister's Office (EIDPMO), together with several operator and service companies from the oil and gas industry, which contributed to the funding of this project and provided consultation expertise during its construction. Students from IBTE, who are part of the Higher National Technical Education Certificate program, National Technical Education Certificate Education Certificate program and the

Industrial Skills Qualification Program will be the main beneficiaries of this mini plant and will make use of this facility over the course of their education.

The introduction of this mini plant served to support IBTE's vision of providing first class training equipment to help develop highly skilled, job-ready graduates to meet industry requirements and standards. Doing so will provide opportunities for instructors from the industry to train and develop the IBTE students' skills through continuous professional development, upskilling, and competence upgrading, among other methods.

Dr Chin Wei Keh, the Director and CEO of IBTE said in his speech during



the opening ceremony, "This project is a good example of a 'whole-of-nation approach' as it is a collaborative effort bringing together partners from across industries, ministries and government agencies, exemplifying the vital importance of increasing links between stakeholders."
